PH CEOs brace for further revenue losses in 2021 due to COVID-19

Most chief executives. The rest of the respondents are surveyed by PwC from micro, small, medium-sized enterprises (MSMEs). The results of the survey, which was conducted from April to May this year, show that 79 percent of CEOs consider an "effective and equitable vaccination program" as one of the most urgent measures the government should implement to help their respective industries recover from the impact of COVID-19. Some 69 percent of them expect their workforce to be fully vaccinated

by January 22, 2022. The Right of Way survey on 131 CEOs, 62 percent of whom represent large companies belonging to the top 0.5 percent of registered busi-

This year. Also, 40 percent of the respondents said their businesses had so far incurred actual losses ranging from 20 percent to 50 percent. When asked to select the major factors behind the losses, most of them pointed to lower sales because the time when the consumer demand got affected (44 percent) and because businesses closed in certain months of the year (34 percent).

The survey was conducted around the time when the healthcare system got overwhelmed by a surge in COVID-19 infections, leading to a revert to the most stringent of quarantine restrictions that have wreaked havoc on the economy.

Growth forecasts kept but Delta variant threatens recovery

While Metro Manila and neighboring areas moved closer to achieving herd immunity, boosting hopes that the country could finally return to growth path, the more contagious Delta variant of COVID-19 may further slow down the reopening of the economy, think tanks said. In a report, Pantheon Macroeconomics senior Asia economist Miguel Chancho said the economic impact of the Delta strain would likely be felt by the fourth quarter of this year. "The economy's prospects in the current quarter are likely to be spared, not least

because the government has demonstrated consistently an unwillingness to impose the stringent social-distancing measures needed until the very last minute ... It probably will take longer for Delta to take hold in the Philippines, due to the still-subdued levels of mobility," Chancho said.

Chanco, nonetheless, said that with or without the heightened risk coming from the

Delta variant, domestic demand would be "extremely challenging" as uncertainty due to the prolonged pandemic tempered consumer spending. Transact only with registered payment system operators, BSP tells public

The central bank urged the public last July 19 to deal only with legitimate payment system operators

to help ensure that their rights as consumers are fully protected.

In a statement, the Bangko Sentral ng Pilipinas (BSP) said Filipinos should deal with, entertain product offerings, or carry out financial transactions only with BSP-registered Operators of Payment Systems.

Under BSP regulations, operators of payment systems include cash-in service providers, bills payment service providers, and entities such as payment gateways, platform providers, payment facilitators, and merchant acquirers that enable sellers of goods and services to accept

payments, in cash or digital form. The registration of a payment system operator allows the central bank to have oversight when making financial transactions to help ensure that their rights as consumers are fully protected.

If the payment system remains unregistered, the Monetary Board shall issue an order for the entity to stop from operating a payment system without registration and to take immediate action to register.

All payment system operators must register with the BSP pursuant to Circular 1049 which provides for the rules and regulations on the registration of operators of payment systems.

According to the central bank rules, when a payment system operator is found to be operating without registration, the Monetary Board shall issue a di-

rective to the entity to comply with the registration requirements.

The central bank may coordinate with other regulators and concerned government agencies to inform them that the entity is operating a payment system without registration, and may be subjected to enforcement actions by the regulator.

At present, there are 150 accredited payment system operators, with the oldest having been accredited since late 2019 and the newest receiving central bank imprimatur only earlier this month.

BSP reminds banks to ease services for PWD clients

The Philippine central bank wants financial institutions in the country to make it easier for persons with disabilities to transact with them

by providing additional services to aid those who are visually impaired as well as those with mobility limitations.

In a statement, Bangko Sentral ng Pilipinas (BSP) Governor Benjamin Diokno also reminded banks not to turn away prospective PWD clients or insist that they open only joint bank accounts.

To this end, the regulator has issued a memorandum to all BSP-supervised financial institutions to remind them to refrain from discriminatory practices against persons with disabilities. This was to ensure that their PWDs' rights were respected at all times.

To further support the welfare of PWDs, the BSP introduced enhanced tactile marks in Philippine banknotes to provide express lanes for PWDs—similar to those reserved for senior citizens and pregnant women—within their premises.

The memorandum sternly reminded financial institutions to adhere to laws and regulations against discriminatory practices toward PWDs, including but

not limited to: Refusal to accept government-issued PWD ID cards for account opening and other transactions

Turning away blind people who are trying to open accounts Requiring blind people to open only joint accounts with those who are not visually impaired

Aside from putting in place mobility ramps and the Braille system in bank premises and automated teller machines, financial institutions are also reminded

"The BSP lauds the National Council on Disability Affairs and other stakeholders for upholding the rights of the PWD sector," Diokno said. "Rest assured the BSP is committed to continuously engage the sector and better respond to the needs of PWDs."

"Empowering vulnerable sectors has always been an underlying objective of the BSP's efforts," he added. "For this reason, we are stepping up our financial inclusion efforts to ensure financial services are within easy reach for all Filipinos, including PWDs."

Self-employed, voluntary SSS members up 20%

The number of self-employed and voluntary members (SEVMs) of the state-run Social Security System (SSS) rose 20 percent to 8.43 million as of end-May, making up one in every five members of the provident fund's 40.52 million membership base.

SSS president and CEO Aurora Ignacio said the agency would sustain efforts to register more

SEVMs and provide social security benefits to individuals displaced by the pandemic.

Similar to their regular counterparts, SEVMs are entitled to apply for social security on sickness, maternity, disability, retirement, death and funeral.

"Being part of the 3.73 million unemployed individuals, they are deemed as the most vulnerable members of society. SSS coverage is the most affordable form

of social security they can avail of," Ignacio said.

Based on the latest labor statistics, around 3.73 million Filipinos remain unemployed due to the recession.

SEVMs are also qualified to secure loans for salary, calamity and education, as well as pension by the time they retire.
