## Cavite eyeing P200-B bonds for new airport

The Cavite provincial government plans to issue P200 billion worth of bonds to raise funds for the proposed international airport in Sangley Point and meet the Transportation Department's deadline to resolve its financial issue.

"We're looking towards a bond float to start everything out with the province as one of the initiators of the bond float. We are looking towards a local consortium," Cavite Governor Jesus Crispin Catibayán Remulla said.

"Initially, we're looking at P200 billion; it should be enough."

MSMEs during the training.

The training on Business Continuity Plan (BCP) aims to promote and develop awareness, appreciation, and understanding of the business continuity management concepts, practices and requirements as applied to the MSME context.

"We, in the DTI, recognize the major role of our MSMEs in the country's economic development through income and job generation. Thus, in Calabarzon, we want to enable our MSMEs to understand the process in developing Business Continuity Plans (BCPs)," DTI Regional Director

Marilou Q. Toledo said.

Toledo told the participating MSMEs from Cavite, Laguna, Batangas, Rizal and Quezon that business continuity planning serves as a very helpful tool to help them prepare for future disruptions to their businesses.

"After this training program, we want to transform our MSMEs to 'resilient MSMEs,'" Toledo added.

The modular training program was based on the simplified training module prepared by PDRF aligned with the Asia-Pacific Economic Cooperation (APEC) SME Guidebook on BCP.

This module covers introduction to the

Business Continuity Management Framework, overview of the BCP in the MSME context, risk assessment, business impact analysis, and the development and implementation of business continuity strategies and the BCP.

The training is in response to a survey conducted by its Bureau of SME Development and the Asian Disaster Preparedness Center,

which revealed that only a minimal 6 percent of the 513 survey respondents from all over the Philippines have a BCP in place.

The regional trade and industry office expressed that training activities on BCP for

MSMEs have the potential to raise awareness on the importance of business continuity in private sector resilience and community resilience.

According to the DTI regional office, an efficient and effective business continuity program should be applicable to any enterprises for them to recover and survive after a disaster.

Since MSME development is one of the trade and industry department's core functions, it also strengthens the capacity and knowledge of its Negosyo Center staff to enable them to help enterprises to be resilient in times of disasters.

pines Co-founder and Chief Executive Officer Paulo Campos III said it has partnered with Ayala-led AC Infrastructure Holdings Corp. (AC Infra) for the construction of a 40,000-square meter (sq.m.) New Fulfillment Center located

on a 3.7-hectare property near the Muntinlupa-Cavite Expressway.

"We're experiencing really accelerating

growth and tremendous, (especially) on super peak days. We really have had to build out a new facility," Mr. Campos told reporters in a media roundtable discussion in Taguig City last March 27.

"It's a build-to-suit facility that will feature very innovative conveyor technology, some forms of automation, and increase the throughput."

The New Fulfill-

ment Center will have a capacity of 7.2 million items, six times more than its capacity of 1.2 million items at its Carmona warehouse.

"Our strategy is to retain the one ful-

fillment center strat-

egy... We could use it (the Carmona site) for (Entrego's) expansion. We would potentially make use for it as an alternative site," Mr. Campos said, referring

to its last mile logistics service, Entrego.

AC Infra is funding the construction of the facility that is scheduled to be completed by December 2019. Zalora Philippines will then lease out the property from AC Infra.

The warehouse will also include a 5,000-sq.m. office space, which can employ up to 1,200 employees.

Tugade earlier said he would keep his options open for Sangley, adding that there was a similar unsolicited proposal from Solar Group's All-Asia Resources and Reclamation Corp. which was submitted to the department in 2016.

The AARC unsolicited proposal to build the Philippine Sangley International Airport

during the project development phase.

ARRC proposed a concession period of 50 years for the Sangley International Airport.

Under the proposal, the project will start with the reclamation of about 2,500 hectares of land north of the Sangley peninsula which will be used for the development of the airport in

infrastructure and a commercial establishment to complement the project.

Sangley airport would be designed with two parallel runways

and sufficient airside and terminal capacity to accommodate future demand for the domestic and the international traffic, not only for the Philippines but also for Southeast Asia.

## BSP noncommittal on policy easing despite lower March inflation

The central bank cheered the latest inflation rate, which slowed last year to combat surging prices. In an SMS message to the press, Bangko Sentral ng Pilipinas

(BSP) Governor Benjamin Diokno said the 3.3 percent inflation rate for last month was "consistent" with authorities' expectations that "inflation will continue

to settle within the target range for 2019 and 2020."

At the same time, however, the new central bank chief raised the likelihood of resurgence in inflation rate due to "the possibility of a stronger and prolonged El Niño episode together with the continued rise in global crude oil prices" which would "provide upside price pressures over the near term."

On the other hand, Diokno said "the potential slowdown in domestic economic activity due to the budget impasse as well as continued uncertainty in the global economic environment could present downside risks to inflation."

Last April 5, the Philippine Statistics Authority (PSA) announced that March inflation rate had dropped to its lowest level in 15 months, since the 2.9 percent recorded in December 2017.

PSA data showed price increases in seven commodity groups decelerated last month, namely: food and non-alcoholic beverages; alcoholic beverages and tobacco; housing, water, electricity, gas, and other fuels; furnishing, household equipment, and routine maintenance of the house; health; communication; and restaurant and miscellaneous goods and services.

In the first quarter of 2019, headline inflation averaged 3.8 percent - within the government's 3-4 percent target range.

Diokno had earlier advocated looser monetary policy - possibly through a reduction in banks' reserve requirements or a cut in the BSP's overnight borrowing rate.

# US envoy says China activities near Philippines 'of concern'

The presence of large numbers of Chinese vessels near islands and islets occupied by the Philippines is "a concern," a senior U.S. defense official said April 5.

He noted that the U.S. does not take a stance on various conflicting claims in the South China Sea. But the U.S. commitment to the Indo-Pacific region involves working with allies and partners to keep the seas free and open and ensure that more than 200 Chinese vessels from January to March in a disputed he said.

The Philippine government protested Chinese ship movements last April 4 after its military monitored more than 200 Chinese "no country's sovereignty is undermined," he said.

"We expect every country to be able to sail, fly and operate wherever international law allows."

Asked about the situation while on a visit to Bangkok, Joseph Felter, deputy assistant secretary of defense for South and Southeast Asia, told reporters that the U.S. is troubled "by any aggressive activity under its western prov- by any country in the case of Palawan. That South China Sea, in this case China. We see that as of concern."

"In this case, China's activities are of concern. It seems to be somewhat aggressive and provocative and we feel that they're unnecessary and unwarranted," said Felter, who was in Thailand to attend a meeting of defense officials of the Association drawing rebukes from other claimants as well as Washington.

Chinese boats have swarmed around Sandy Cay, a chain of three sandbars between Pagasa and a Chinese man-made island called Subi, since 2017. Such practice could be meant to pressure other governments into abandoning their islands.

A 2002 accord between China and the 10-nation ASEAN aims to prevent armed confrontation in the busy waterway, where much of Asia's oil and trade transits.

Felter said the meetings he attended also addressed the lingering threat from the extremism and the Islamic State group in Southeast Asia and the U.S. looks forward to working with regional partners on counterterrorism.

"It's a threat. We've degraded ISIS in the Middle East significantly as far as its territory but importantly, over the last few years, China has stepped up its territorial claims by turning lands it controls into military installations, probably haven't seen the last of this," he said.

## Philippine dollar reserves rise for fifth straight month in March

A steady inflow of foreign currency boosted the Philippines' dollar reserves in March, marking its fifth straight month of increases, the central bank said last April 5.

In a statement, Bangko Sentral ng Pilipinas Governor Benjamin Diokno said preliminary data showed that the country's gross international reserves rose to \$83.2 billion as of end-March 2019 from \$82.78 billion as of end-February 2019.

"The GIR level rose due mainly to inflows arising from the national government's net for-

ign currency deposits, BSP's foreign exchange operations and income from its investments abroad," he said.

This increase in reserves was tempered partially by payments made by the national government for servicing its foreign exchange obligations as well as revaluation losses from the BSP's gold holdings, resulting from the decrease in the price of gold in the international market.

Diokno said the end-March 2019 dollar reserve level "serves as an ample external liquidity

## China Bank set to raise P75B via bond offer

By family-led China

Bank is setting up a P75-billion bond program for the next three years, joining the bandwagon of banks tapping the bond market to fund robust lending activities.

Such a bond program gives Chinabank more options to raise funds and reduce reliance on deposits.

Chinabank's funding exercise of up to P75 billion will be done in several tranches for the next three years.

These may be in the form of retail bonds and/or commercial paper.

Retail bonds are long-term debt paper while commercial paper are short-term unsecured promissory notes or IOUs.

The proceeds shall be used to support the bank's strategic initia-

tives and expansion programs. This is in line with the bank's intention to be an active participant in the ongoing economic expansion of the country and the government's infrastructure initiatives.

Such a bond program gives Chinabank more options to raise funds and reduce reliance on deposits.

Chinabank has secured board approval to issue these IOUs.

The BSP recently issued new rules that made it easier for banks to issue bonds.

Previously, the BSP required banks that would

like to offer bonds to back up 100 percent of these bonds with government securities as collateral.

If the bank won't use government securities as collateral, then the value of collateral must exceed that of the issue size.

# DOF: Record current account deficit could weaken peso

The peso could weaken amid a widening current account deficit even as it strengthened against the US dollar in the first quarter thanks to solid macro fundamentals, the Department of Finance (DOF) said last April 5.

In an economic bulletin, DOF Undersecretary and chief economist Gil S. Beltran said the peso appreciated by 0.01% versus the greenback as of end-

March as the domestic currency "tracked its peers in Southeast Asia in gaining strength against the US dollar."

The Chinese yuan, Indian rupee, Indonesian rupiah, Malaysian ringgit, Singaporean dollar, Thai baht, and

Vietnamese dong also gained against the US dollar year-to-date as of March 29.

On the other hand, the Hong Kong dollar, Japanese yen, New Tai-

wan dollar, and South Korean won were weaker than the greenback during the first three months.

The peso was also stable, as its volatility, measured by the coefficient of variation, was 0.56 percent.

A currency's volatility refers to the magnitude of its fluctuation against the US dollar.

Moving forward, Beltran said "the outlook for the peso re-

mains tilted towards the downside owing to a growing current account deficit, which, in turn, is on account of increased importation of capital goods."

The current account deficit ballooned to a record \$7.9 billion last year as more dollars were being spent on imports.

Economic managers had said that with the ambitious "Build, Build, Build" infrastruc-

ture program of the Duterte administration remain high at \$42.9 billion, equivalent to 7.3 months of imports for imports of mostly capital goods would remain strong in the near term.

## Hari sees up to 27% growth in sales in '19

The official distributor of Hyundai vehicles in the country targets to sell up to 45,000 units this year, a 27-percent growth that will enable the company to recover sales volume losses in 2018.

Hyundai Asia Resources Inc. (Hari) president and CEO Ma Fe Perez-Agudo said on the sidelines of the Manila International Auto Show (MIAS) last April 4 that sales rose by 16 percent in the first two months of the year.

Perez-Agudo said during the event that Hyundai's latest additions to its lineup, which she called "rock stars," included the Palisade, the biggest SUV yet, and the Kona Electric, the country's first electric sports utility vehicle, which were both

launched last April 4. Wearing a leather jacket with the word "queer" written in sparkling purple, the company chief said Hyundai had been doing great so far.

"We're doing great. We had a 16-percent increase [in the first two months of the year]. We'll try to achieve about 40,000 to 45,000 [unit sales] this year," she told reporters.

In 2018, Hari's sales fell by 6 percent,

reflecting the decline in the total sales of the industry given the impact of elevated inflation and high excise auto taxes on demand for new vehicles.

Hyundai sold 35,401 units last year, lower than the 37,678 units sold in 2017.

## Filipino workers in Indonesia mine site landslide safe -DFA

There were no Filipino casualties in a landslide that hit a mine site in Indonesia, the Department of Foreign Affairs (DFA) said last April 5.

In a statement, the Philippine Consulate

General in Manado and Acting Head of Post Manuel Ayap said that all 48 Filipinos working at the mine site are safe.

The Consulate General was also able to contact the Filipinos in PT Freeport, who con-

firmed that they are all safe and were not affected by the landslide," DFA said in a statement.

Ayap also advised Filipinos to be extra vigilant and to observe their company's contingency plan in cases of emergencies.

# UN unit sees PH economy growing by 6.5% in '19

The United Nations Economic and Social Commission for Asia and the Pacific (Unescap) expects the Philippine economy to grow by 6.5 percent this year despite slowing growth across the region amid trade tensions between the United States and China.

In the Asean, the gross domestic product (GDP) growth forecast for the Philippines was exceeded by Myanmar's 7.2 percent, Cambodia's 7 percent, Laos' 6.8 percent and Vietnam's 6.7 percent, according to Unescap's flagship "Economic and Social Survey of Asia and the Pacific 2019: Ambitions beyond growth" report which was released last April 4.

Unescap's updated growth forecast for the Philippines was higher

than last year's actual GDP growth of 6.2 percent and in the midrange of the government's downgraded 6.7 percent target. It is, however, lower than the 6.9 percent projection in its 2018 flagship report.

To recall, the Cabinet-level Development Budget Coordination Committee (DBCC) last month slashed its GDP growth target for this year to 6.7 percent from 7-8 percent previously as the government operated on a reenacted budget in the first quarter, limiting spending on public goods and services.

The Department of Finance said the other week that in the first two months of the year, the government was unable to disburse P43.7 billion for its priority programs and projects, including

infrastructure, as the impasse on the proposed P3.75-trillion 2019 national budget dragged in Congress. The 2019 budget is now up for President Duterte's approval.

In 2020, Unescap expects the Philippine economy to grow slightly faster at 6.6 percent, which is also within the government's downgraded 6.5-7.5 percent target range for next year.

After headline inflation hit a 10-year high of 5.2 percent last year, Unescap sees an easing in the rate of increase in the prices of basic commodities, projecting an average of 4 percent this year and 3.5 percent next year, returning within government target range of 2-4 percent.

## IRR for rice tariffication law out; cheaper rice prices seen

Rice prices are expected to be cheaper by up to P7 per kilo with the release of the implementing rules and regulations (IRR) for the law easing importation to guide trade of the Filipino staple food.

The IRR of Republic Act No. 11203 or the rice tariffica-

tion law was contained in the 31-page Joint Memorandum Circular 01-2019 signed by Agriculture Secretary Emmanuel F. Piñol, Socioeconomic Planning Secretary Ernesto M. Pernia, and Acting Budget Secretary Janet B. Abuel.

The IRR will take

effect 15 days upon publication.

But RA 11203 already took effect last March 5, under which its self-executing provisions, including the following tariff rates, now apply: 35 percent if rice was imported from within Asean; 40 percent if within the

minimum access volume (MAV) of 350,000 metric tons for imports coming from countries outside Asean; and 180 percent if above the MAV and from a non-Asean country.

Previously, rice had an import quota dubbed "quantitative restrictions" (QR) aimed at protecting local farmers.

The QR had put the burden of rice supply and demand to the government, while market forces were limited by the quota system.


But economic managers had deemed that private sector-led importation will allow market forces to determine prices and bring

them down.

When the government imposed a quota on rice imports, domestic prices were vulnerable to shocks resulting from meager supply, as what happened last year when stocks got depleted, contributing to the 10-year high inflation of 5.2 percent in 2018.
