

"Nevertheless. the sustained implementation of targeted fiscal mitiatives. as well as the acceleration of the vaccination program, should help boost market confidence and economic recovery." Diokno said during the 10th Arangkada Philippines Forum. held online by the Joint Foreign Chambers of Commerce of the Philippines.

Sans any hitches, strong growth should still be expected in 2022 he said.

He noted that since the start of the year, the domestic economy has grown by an average 4.9 percent


